
### **Discipline Committee Report 2017-18**

- 3 meetings were conducted under the LMC member, Principal and all committee members for various disciplinary issues and necessary actions were taken immediately followed by it.

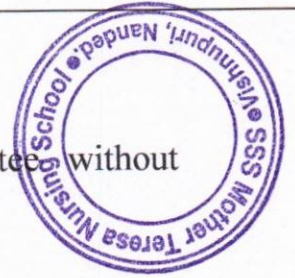
Details are as follows:




2. In academic year 2 meetings were conducted for various disciplinary issues and necessary actions were taken immediately followed by it.


